An Affidavit of Identity can prove your identity when requested by a court or financial institution. Create an Affidavit of Identity when you need evidence of

How to Obtain a Certified Copy of a Birth Record

A notary public or other officer completing this certificate verifies only the identity of the individual who signed the document to which this certificate is attached, and not the truthfulness, accuracy, or validity of that document.

A verification on oath or affirmation is a voluntary, sworn written statement. One verification on oath or affirmation statement is provided by RULONA. The name of the affiant (the person giving the statement) must be mentioned in the affidavit and the affiant is required
